### Parents or legal guardians are responsible for the following rules:

- Participants must check in at the Courtesy Desk each time when entering the facility.
- Parent must provide child with proper swim attire.
  - For Aquababies, a swim diaper is required. For Advanced Aquababies a swim diaper is required if the child is not potty trained.
- Parents **cannot** leave any children unattended on the pool deck. A responsible adult must be on deck during child's swimming program.
- No use of cell phones in the locker room and no cell phone talking on the pool deck.
- As an adults only member facility, parents must supervise their children in the locker room. This includes :
  - Monitoring your child's behavior at all times
  - Being aware of other members/guests at all times
  - Consistent use of the baby changing stations in the locker rooms and in the designated family changing areas
- The Quiet Zone(the hallway in between the locker rooms) is unavailable unless necessary due to the age of the child and you are walking them from the fitness floor..
  - Please be sure to use your inside voices.
- At the beginning of each class all students (and parents in Aquababies) will be lined up and enter class in a systematic and safe process.
  - Parents of Aquababies should enter the pool through the assigned stairwell to ensure safe entrance.
  - No strollers allowed on the pool deck
    - Stroller parking is located outside of our KidCenter.
- Additional children not participating in class must have another adult present with them on the pool deck and must be in compliance with all behavioral expectations.
